

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY

In consideration of being given the opportunity to participate, in any way, in any sports related activities (Activity) organized , conducted, supervised, or managed by MySportsCamp LLC, I for myself and my personal representatives, assigns, heirs, and next of kin:

1. **Acknowledge**, agree, and represent that I understand the nature of Sports Activities and that I am qualified, in good health and proper physical condition and otherwise able, without undue risk, to participate in such Activity.
2. **Fully understand** that: (a) Sports Activities involve risks and dangers of serious bodily injury, including, without limitation, permanent disability, paralysis, and death; (b) these risks may be caused by my own actions or inactions, the actions, or inactions of others participating in the Sports Activities, the nature of the Activities taking place or the negligence of any released party hereunder; (c) there may be other risks, including social economic losses, either not known to me or not readily foreseeable at this time arising out of my participation in the Sports Activities. Accordingly , I FULLY ACCEPT AND ASSUME ANY AND ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN THE SPORTS ACTIVITIES AND SHALL BE SOLELY RESPONSIBLE FOR ANY LOSSES, COSTS AND DAMAGES that I may incur as a result of my participation in the Sports Activities.
3. **Release, discharge and covenant not to sue** MySportsCamp LLC and their affiliates and their respective members, managers, directors, agents, volunteers, and employees and heirs, personal representatives, successors and assigns (collectively referred to herein as the "Releases") from any and all liabilities, claims, actions, demands, losses, costs, expenses or damages of any nature whatsoever, known or unknown, arising out of any injury to person or property by reason of my participation in the Sports Activities, including, without limitation, the negligence of the Releases. I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity, I, or anyone on my behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the Releases from any losses, liabilities, damages, or costs/expenses, including , without limitation, reasonable attorney fees and litigation and court costs, which any Releases may incur as a result of such a claim or my negligent, improper, or unlawful conduct; and
4. **Have read this Release and Waiver**, fully understand its terms, understand that I have given up substantial rights by signing this Release and Waiver and have signed it freely and without inducement or assurances of any nature. I intend this Release and Waiver to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Release and Waiver is held to be invalid the balance notwithstanding, shall continue in full force and effect. I further acknowledge that I have been advised to seek legal counsel to review this Release and Waiver prior to my signature.
5. While participating in activities run by MySportsCamp LLC and Affiliates, I agree to conduct myself in a manner reflecting good sportsmanship, courteousness, and respect for others including coaches, and other participants. Failure to abide by any portion of MySportsCamp LLC policies shall be reason for expulsion from Sports Activities without refund.
6. Under the "Good Samaritan Act" I authorize MySportsCamp LLC or any of the "Releases" to administer any necessary emergency medical care, or to call local EMS if necessary on my behalf.

Parental Consent

I, the minor's parent and/or guardian, have read and agree to all of the foregoing provisions. I understand the nature of Sports Activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such Activities. I hereby **Release, Discharge, and Covenant Not to Sue**, each of the Releases from all liabilities, claims, actions, demands, costs, expenses, losses or damages, of any nature whatsoever, known or unknown, arising out of any injury to person or property by reason of the minor's participation in the Sports Activities. I will **Indemnify, Save, and Hold Harmless** each of the Releases from any losses liabilities, damages, or costs/expenses, including, without limitation, reasonable attorney fees and litigation and

court costs, which any Releases may incur as the result of any such claim or the minor's negligent, improper, or unlawful conduct.

I, or the minor's parent and/or guardian, have read and agree to the forgoing provisions.
